

Superfly 2002

You won't want to miss the annual SUPERFLY competition in the waters of the Upper Gunnison basin. This year's SUPERFLY is scheduled for Saturday, August 10th. The festivities begin with a relaxed reception on Friday evening, where all the participants can get to know each other and their guides. On Saturday, the day will kick off with breakfast and then teams will fish their first "beat". A box lunch is provided for midday, then teams move onto their second "beat" for the afternoon. Beats are drawn randomly and include a mix of public and private waters along the East, Taylor, and Gunnison Rivers. Then, on Saturday evening, all SUPERFLY contestants will receive complementary tickets to the Gunnison Angling Society banquet.

Each SUPERFLY team is made up of two anglers, each of whom can register two competition flies. Guides will measure the length of each trout caught on the competition flies, with prizes going to the team that catches the most total inches of trout as well as special prizes for the biggest fish, the top individual, and the top TU Chapter team (for those teams representing specific TU chapters).

Registration for SUPERFLY is \$400 through July 15th, and includes the Friday reception and all three meals on Saturday as well as guided fishing for both beats. After July 15th, registration goes up to \$450. All proceeds go to support the Gunnison Angling Society and Colorado Trout Unlimited.

Political vs Ecological Reality

With a key vote on opening the Arctic National Wild life Refuge to oil drilling expected in the Senate this week, the Bush administration has rejected its own environmental review and demanded that government scientists instead issue a "quick follow-up report suggesting that the most likely drilling scenarios under consideration should have no impact on caribou" says the Washington Post 4/7. The original peer-reviewed analysis by government scientists looked at 12 years of research and warned that drilling in the Arctic Refuge could "pose substantial risk to caribou and other wildlife", but the scientists were given a whole week to come up with a new "revised", politically correct report.

CTU Spring Rendezvous 2002

TU In The Colorado Supreme Court

On April 8th, Melinda Kassen, lead attorney for the Colorado Water Project, filed an amicus ("friend-of-the-court") brief with the Colorado Supreme Court in the City of Golden's boat chutes case. Previously, Golden filed to establish substantial in-channel water rights for its world-class boating course on Clear Creek. Golden's claims were upheld by the water court, and Golden obtained an in-stream water right for Clear Creek. The State of Colorado, Division of Water Resources and the Colorado Water Conservation Board, agencies which oppose Golden's claim, and similar claims for in-stream water, appealed that decision to the Colorado Supreme Court. TU filed its amicus brief in support of the City of Golden.

TU was joined in its brief by a number of other environmental and recreation groups, including the High Country Citizens, the San Juan Citizens Alliance, the Colorado River Outfitters Association, and the American Canoe Association.



While the amicus brief addresses complicated points of Colorado water law, the overall theme is quite simple: in-channel water rights for recreation are not "second class" water rights but must be treated just as any other claim of water for beneficial use. The State has argued that these water rights should be subject to a number of tests and limitations that apply to no other water users, while the TU brief points out that there is no basis in law for that kind of discriminatory approach to recreational water rights.

While the brief focuses on points of law, recognizing recreational and in-channel uses of water makes good sense from a public and economic policy standpoint as well. Water-based recreation is increasingly important to Colorado's economy -- for example, fishing generates \$1.3 billion to the state's economy each year, and commercial rafting generates another \$123 million. Beyond dollars and cents, flowing streams also contribute to the quality of life for Coloradans. TU continues to support these in-stream uses of water. While the state has argued in this case that such in-channel uses of water are somehow less beneficial and should be more tightly limited than other water rights, TU believes that in-stream water rights should be given fair and equal treatment with out-of-stream uses. Oil and Gas Plan Threatens Fisheries

TU is deeply concerned that the Bureau of Land Management (BLM) is backing away from existing protections to coldwater fisheries and allowing new development of oil and gas resources on public lands without adequate commitments to reclamation and monitoring.

Current efforts to implement the Administration's energy plan by BLM assert oil and gas development as a dominant use of public lands and place protection of watershed health as an "impediment" to production. Emphasizing the production of public land energy resources at the expense of fish and wildlife habitats and drinking water supplies is a short road to prolonged conflict and long-term ecological degradation. Once rivers are polluted or watersheds are damaged, their recoveries are slow and expensive. Existing regulations opened millions of acres of land to drilling activities throughout the Rocky Mountain Western states. TU encourages the BLM to continue its current policies to aggressively protect our waters and rivers at the same time oil and gas activities are allowed.

At a recent press conference in Denver, TU's Wyoming Water Project Director Laurie Goodman said, "People from Wyoming and Colorado support multiple use management of public lands, but only if it does not compromise the health of our rivers and watersheds."

The "Pinedale Anticline" development in Wyoming may provide an example of how development and conservation may co-exist. In early March, a Federal District Court upheld the BLM's Record of Decision on an Environmental Impact Statement (EIS) for over 200,000 acres of land that was completed within 25 months. This required an Adaptive Management Process and the court praised BLM's adoption of the system, along with continued public participation in the monitoring of impacts. This EIS should be a model for future National Environmental Policy Act and permitting decisions allowing oil and gas operations by the BLM. It can provide for full public involvement, minimize industry uncertainty, and provide flexibility in leasing decisions so that land managers may retain the discretion to take prudent steps to protect land and watershed health.

CA Tribes Want More Water For Salmon

The Hoopa and Yurok tribes in northwest California areasking a federal judge to leave more water in the Trinity River for salmon, instead of diverting about 75% of the flow for hydropower and Central Valley agribusiness says the SF Gate, AP 3/14. Irrigators are challenging a decision by former Interior Secretary Babbitt to preserve about half the Trinity's natural flow for the fish.
