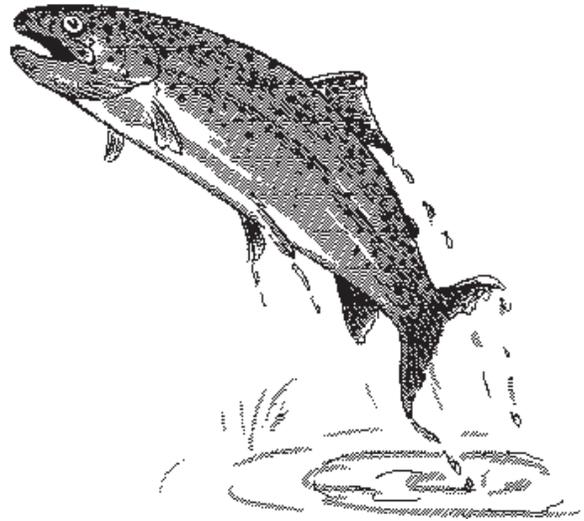

From The Prez,

My page this month will also recap the February Board Meeting, since Ron Belak couldn't attend.

The ETU Board Meeting was held February 26th, at the Rib Crib Otherside, at 6:30p (4th Wednesday, as always). About a dozen members attended. Dave Blauch, Senior Ecologist with Ecological Resource Consultants, Inc. kicked things off with a presentation of the final Bear Creek Project grant proposal.

This exciting project entails **stream rehabilitation (and more), of 1,500 linear feet of Bear Creek**, in O'Fallon Park. The total estimated project cost is **\$184,000**. We are seeking approximately **\$120,000** from the Colorado Division of Wildlife's (CDOW) Fishing is Fun program. These "FIF" grants are funded, federally, by license fees and taxes on outdoor related purchases by all of us. The CDOW administers these grants in Colorado. ETU has committed to raise **\$10,000 cash** for the project, and approximately **\$50,000 in 'in kind' donations**. 'In kind' refers to our volunteer labor, donations of boulders from CDOT, labor from Denver Mountain Parks, labor from TENAS (The Evergreen Naturalists Audubon Society), etc. Conditional approvals will be announced in June 2003, although the actual work wouldn't begin until September 2004.

As the time approaches, we'll need **strong chapter support** with this, in many ways. We're all very elated to finally have a meaty project in the works. We'll keep you posted as this progresses.

Other items reviewed included our fly tying classes at **Mount Evans Outdoor Lab**, which have

been running smoothly under Len Wheaton's direction. We're trying to correct the problems with their fish tanks. Also, the **"Trout in the Classroom"** aquaria are doing well under Craig Dunham's supervision. Our venue change to the Evergreen Hotel for the general meetings also went off without a hitch. We will attempt to have the doors open at 6:00p for the March meeting. Details on this month's program -- Flyfishing the North Platte River -- are inside.

In other news, we're in need of volunteers for the annual **Earth Day Fair** on Saturday April 19th, and our semi-annual **Bear Creek Cleanup** on Saturday April 26th. We're also looking for any of you to help sponsor the newsletter (which costs us \$150/month). More on this inside, as well. ETU has approximately \$8000 to our name currently, and with the commitments we've made, we'll need to do more fundraising this year. Keep in mind, ETU a registered non-profit organization, and any donations may be tax deductible. (Obligatory disclaimer: Your actual mileage may vary. Contact to your favorite tax accountant for details).

Finally, **a correction**. The minutes of the January Board meeting (in last month's issue) incorrectly attributed the Bear Creek Study to Ecological Resource Consultants. It was actually produced by **Chatwick Ecological Consultants**. We apologize for any copnfusion that this may have caused.



AB Lateral Threatens Gunnison River

In 1984 and 1988, respectively, the Uncompahgre Valley Water Users' Association (UVWUA) was awarded two conditional water rights for the **AB Lateral Hydroelectric Project** (conditional rights are water rights that would maintain UVWUA's priority date pending actual construction of the project). The rights would allow it to **divert water from the Gunnison River** above the Black Canyon to the Uncompahgre Valley for hydropower production. The AB Lateral Hydroelectric Project is still not operational, and accordingly the water rights remain conditional. As is required by Colorado law to retain conditional rights, UVWUA recently filed applications in water court seeking to demonstrate that it has been diligent in its efforts to complete the project.

UVWUA already possesses water rights to divert water from the Gunnison for irrigation purposes in the Uncompahgre Valley. The AB Lateral rights, if ever perfected, **would allow UVWUA to substantially increase its diversions, particularly in the non-irrigation season**. The results would be destructive for both the Gunnison and Uncompahgre Rivers. On the Gunnison, the project will deplete flows for the world-class trout fishery in the Black Canyon and Gunnison Gorge. While the Gunnison does sometimes experience 300 cfs minimum flows, such **low flows could become a permanent way of life** for the river if the AB Lateral project is completed. On the Uncompahgre, which naturally has much lower flows than the Gunnison, the reverse is the problem: after the water is used for hydropower production it will be discharged to the river, causing **flooding and erosion** of farms, ranches and riparian wetlands.

In the forthcoming water court proceedings, UVWUA

will be required to show that it has made diligent efforts towards applying its conditional water rights and that, going forward, it can and will complete the project in a reasonable time. Trout Unlimited has filed statements of opposition with the water court and plans to challenge both showings.

Drew Peterzell, TU's Colorado Water Project staff attorney, explains, "For more than twenty years the Water Users' Association has been thinking about this project, and it is still nowhere close to being on-line. There are a number of **serious obstacles, especially with regard to environmental permitting and compliance**, that the Association would have to overcome before this project can be implemented. We simply don't believe the Association can and will complete the project."

If successful in challenging the AB Lateral diligence claims, Trout Unlimited will ask the court to terminate the conditional water rights. This would finally put to rest a threat that has been looming over both the Gunnison and Uncompahgre Rivers for more than twenty years.

UT Dam Removal One Step Closer

A recently announced dam removal agreement, brokered among a private utility, federal and state agencies, and conservation groups, represents another in a growing number of examples of **traditionally divergent interests working together** for fish and other natural resources.

The agreement, which still must be approved by the Federal Energy Regulatory Commission, provides for the removal of Pacificorp's American Fork Hydroelectric Project and the restoration of **American Fork Creek**, beginning in 2006. Located in a popular canyon along Utah's Wasatch Front, the project consists of a small diversion dam, several miles of pipeline and a powerhouse. The 96 year-old project runs through the Uinta National Forest, including portions of the Lone Peak Wilderness, and the Timpanogos Cave National Monument. At its peak the project could generate about one megawatt of power.

"We thank all of our partners in this agreement for their diligence in the negotiations and their common commitment to this valuable resource," said Alan Matheson, who represented TU in the settlement. "It goes to show that **with a little vision and a lot of hard work** we can take the steps necessary to protect these irreplaceable resources."

Removing the dam and restoring American Fork Creek to a more natural condition will immediately improve water quality, safety and fish migration. A popular recreational fishery for both brown and rainbow trout, **the creek is also home to a fragile population of native Bonneville cutthroat trout, Utah's state fish.**

TU Applauds Clean Water Bill


Trout Unlimited has announced its support of the **Clean Water Authority Restoration Act**. The bill was introduced [recently] in the Senate by Senators Russ Feingold (D-WI), Barbara Boxer (D-CA), Jim Jeffords (I-VT), and in the House by Representatives James Oberstar (D-MN), John Dingell (D-MI), Jim Leach (R-IA) and Sherwood Boehlert (R-NY).

"For the last 30 years Americans have come to take the protections of the Clean Water Act for granted," said Charles Gauvin, President and CEO of Trout Unlimited. "The Clean Water Authority Restoration Act **makes clear what Congress intended when it passed the Clean Water Act in the first place** -- that the Act's protections apply to the broadest range of waters possible."

The purpose of the bill is to restore the full authority of the Clean Water Act in the wake of the **Supreme Court's decision** restricting that authority in the Solid Waste Authority of Northern Cook County (SWANCC) case. This decision, and interpretation of it by the Army Corps of Engineers and EPA, could allow the development and loss of potentially millions of acres of wetlands.

"The Clean Water Act has been critical to fisheries recovery in the United States, and any rollback in the scope of the Act would be a **serious blow** to our trout and salmon watersheds," Gauvin said. "Trout Unlimited strongly supports the bill, and we applaud the sponsors of the bill for their strong conservation leadership."

TU Grassroots Volunteer Hours Up

TU grassroots chapters and councils had another **record-breaking year in 2002**. Based on financial reports submitted for fiscal year 2002 (ending 9/30/02), TU chapters and councils logged a total of **389,862 volunteer hours**, or an average of **over 1,000 hours per chapter**. Nation-wide, this is the equivalent of over 200 full-time staff members.

These hours were spent on a wide range of activities that help protect trout and salmon habitat including: stream restoration and monitoring projects, youth education programs, outreach activities, chapter and council meetings and fundraisers. **TU's network of grassroots volunteers have always been the backbone of our organization.**
