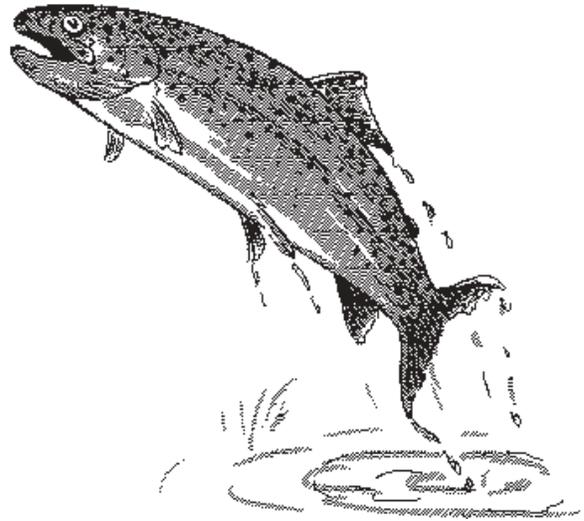

From The Prez,

A change is blowing in the wind this month.

After many years, we finally have nominees together for election of new officers to be conducted at the February 16th general meeting. Continuing the Bear Creek theme, we are in the process of talking to legislators, the Canyon Courier, and other potential allies to petition the EPA to list the stream as impaired. You may remember this was all settled last fall, but then the elections held up the final decision which has been tabled ever since. We're still keeping our hopes up and will let you know if we could use your letter writing help....again. Additionally, we're voicing our opinion as to keeping the tighter fishing regs for Bear Creek in force for another 5-year cycle. We'll provide "in-person" comments to the wildlife commission at the March 10-11 hearings.

I don't know about you, but after having taken the last 5 months off from fishing, I'm ready to hit the waters. To get you further in the mood, we'll have a fly tying demo setup before (and possibly after) the next meeting, starting at 6:00. Plan to come early and learn the basics of fly tying from some of our resident experts. Then enjoy a wonderful program on the Arkansas River by Greg Felt of ArkAnglers.

And please attend the next board meeting at 6:30 pm, Wednesday February 23rd at Beau Jo's.

As Evergreen TU has become more deeply committed to the long-term restoration of Bear Creek, we have been more frequently confronted with the daunting complexities of Colorado water law, federal and state administrative law (particularly enforcement of the Clean Water Act), special district law (particularly regarding water supply/discharger entities), and even personal injury law.

Among our membership of several hundred, we figure there must be several of you who are practicing attorneys. We earnestly invite those who are to consider joining our board to help steer us through the pitfalls and possibilities of our legal options. We need at least one reliable volunteer who can simultaneously coordinate with the Colorado Water Project (which shares offices and duties with CTU in Boulder) and help us focus on our practical problems here in Evergreen. Critical Salmon Habitat Proposal

As President Bush begins his second term in office, his administrative attacks on protections for our nation's endangered fish, plants and wildlife continue. The most recent rollback of protections involves critical habitat designations for endangered and threatened salmon and steelhead in Washington, Oregon, Idaho, and California.

The Bush administration's proposal removes up to 90 percent of salmon and steelhead habitat from protection. One of the most effective ways to protect species is to protect the places where they live. Salmon and steelhead need healthy habitat to survive and thrive. The Endangered Species Act protects the critical habitat that is needed to prevent the extinction of endangered fish, plants and wildlife. The administration's proposal leaves out most of these important habitat areas for salmon and steelhead.

Turning its back on habitat is just one of three major rollbacks that the administration has proposed which threaten to allow pollution and destruction of the Pacific Northwest and California's rivers, streams, forests, salmon, and salmon-dependent businesses and economies. First, several months ago, the administration proposed a policy to allow agencies to count hatchery salmon as wild salmon when determining whether or not to give federal protections to imperiled wild salmon. Second, the administration announced a plan for the Columbia and Snake Rivers that claims the four dams on the lower Snake River are a permanent part of the natural landscape and claims those dams do not hamper future recovery of the salmon. That plan significantly lowers the bar for salmon recovery and protection and will likely drive the fish to extinction. The third policy -- to eliminate or reduce up to 90% of protections for critical habitat -- is strike three! Tell the Bush administration that we will not tolerate such a blatant disregard for our nation's values - send in a comment letter today!

DEADLINE: March 14, 2005

The proposal to reduce protections for so much salmon and steelhead habitat is just one of many attacks on endangered fish, plants and wildlife and the places they live by this administration. We expect such attacks to continue. The administration wants the public to believe that each is just an individual action, but when the puzzle is put together, the American public can see that this is a concerted effort to weaken the Endangered Species Act and the species and landscapes it protects. We owe it to our children and grandchildren to be good stewards of the environment and leave behind a legacy of protecting endangered species and the special places they call home. Let's put the administration on notice that we will not let this happen and we will be vigilant in our efforts to watch their actions.

The Economic Value Of Healthy Fisheries In WY

Years ago, the conservationist Aldo Leopold observed that, "conservation will ultimately boil down to rewarding the private landowner who conserves the public interest." This insight holds true today. Only by exploring ways that economic incentives for landowners can be linked with habitat protection can we protect the open space and wildlife habitats that benefit all Wyoming residents. Toward this end, Trout Unlimited supports the Wyoming State Legislature's creation of the Wildlife and Natural Resources Funding Act as an effective policy vehicle through which landowners and non-profit organizations can work together to ensure that fishery and wildlife habitats remain intact and healthy for current and future generations.

Of Wyoming's 62.5 million acres, public lands cover 57% and private land covers 43%. Agricultural landowners own nearly 98% (about 26 million acres) of the state's private land. Healthy fishery and wildlife habitats exist on both public and private lands and depend on sound stewardship, regardless of land ownership. Terrestrial and aquatic wildlife recognize no land ownership boundaries and depend on migration corridors to cross public and private lands. These corridors have been used by fish and wildlife for thousands of years, and are similar in concept to the migration routes that domestic cattle and sheep have used to move between winter and summering areas for the past 150 years. Migration corridors for fish and wildlife, and the habitats they connect, are essential to protecting the long-term viability of these populations in our state.

Together with the open spaces that support wildlife habitats, healthy fishery and wildlife populations are crucial to Wyoming's economy. Tourism is Wyoming's second largest industry, contributing nearly \$1.9 billion annually to the state's economy and providing over 28,000 jobs. Fishing, hunting and other wildliferelated recreation are key components of the state's tourism industry, and occur on both public and private lands. The environmental and economic integrity of these recreational activities depends largely on the stewardship of private landowners, especially ranchers and farmers.

Like agricultural economies across the country, Wyoming's agricultural industry faces a number of pressures that threaten traditional activities, as well as the fishery and wildlife habitats that agricultural lands typically provide. The ongoing health and vitality of agricultural communities depends on decisionmakers' willingness to support policies that bolster the interwoven and mutually dependent relationship between healthy habitats, healthy economic development and a healthy agricultural industry.
